The last few years have seen an ongoing rebuilding and regeneration of the union movement, and a broadened focus into areas such as productivity, high performing workplaces, Maori workforce development and learning reps.

We are an organising, campaigning union movement; working co-operatively in industries and sectors empowering working people to realise their aspirations and potential, taking an active part in our political democracy and engaging in social partnerships across a broad spectrum of economic and social initiatives in the State and private sectors.

More needs to be done and this year unions will be focusing on extending the rights of freedom of association and collective bargaining to those workers where the 'traditional' form of union membership is not easily attainable. We know modern and successful workplaces will have structures that support union participation and welcome worker voice. Modern workplaces will engage workers in discussions on productivity, innovation and skills training. We also know workers benefit from collective bargaining and that research tells us many workers want to join unions but are not able too. Our challenge is to fill this gap and offer union membership to all workers in New Zealand that want it.

The New Zealand Council of Trade Unions is the largest democratic organisation in the country, representing 350,000 workers in our 37 affiliated unions. This directory provides contact details for the staff at the NZCTU, our representative structures, and affiliated unions (and some non-affiliates) throughout the country.

We expect it will be a useful resource for union officials and staff, workers seeking advice about relevant unions, the media and anyone else with an interest in the union movement.
